- Please note that the buyer must ensure that the vehicle's specifications are adequately suited for its intended purpose and the buyer must confirm that he/she was afforded ample opportunity to inspect the vehicle.
- A vehicle will only be delivered after payment, receipt and clearance of the full purchase price as set out on the tax invoice.
- Kindly take note that, unless where the sales agreement determines otherwise, all vehicles are sold "as is" and the seller will not accept any liability for any latent or patent defects in the vehicle. The seller does not warrant that the vehicle purchased will be usable and durable for a reasonable period, having regard to the use to which they would normally be put and all surrounding circumstances of its supply.
- The seller is under no obligation to register the vehicle in the name of the buyer or to conduct roadworthy assessments, except where the sales agreement determines otherwise.
- Whilst we always attempt to provide accurate descriptions of the vehicle and odometer readings, we do not accept any liability for any act or omission in the case of discrepancies of any nature. The onus remains with the buyer to familiarise him-/herself with all the details of the vehicle. The seller can further not warrant that the vehicle has ever been damaged and repaired to the manufacturer's specification.
- Should a vehicle have an existing manufacturer's warranty the onus to transfer such warranty in the name of the buyer, will be with the buyer.
